RATE DEFINITIONS

***Community Rate**

A group activity consisting of less than 25 participants for which a specific space is requested to be reserved. No funds shall be collected by the permit holder for participation in the reserved activity. The community rate will be offered to 2017 permit holders who provide a valid certificate of liability with an island address, and whose permitted activities provide a service to local island youth.

***Non-Profit Rate**

A group/organization must submit a valid 501c document.

***Corporate Rate**

A group activity consisting of more than 25 participants for which a specific space is requested to be reserved. Additional fees exceeding permit fees and insurance fees are collected.
